1.2 Definitions

- **Account:** A unique profile created to access our Service.
 - **Affiliate:** Any entity that controls, is controlled by, or is under common control with the Company.
 - **Company:** Jamii Coffee LLC, Dundee, Oregon 97115.
 - **Cookies:** Small files placed on your device to track website activity.
 - **Device:** Any internet-connected device such as a computer, smartphone, or tablet.
 - **Personal Data:** Any information that identifies or can be linked to an individual.
 - **Service:** The **Jamii Coffee** website, www.jamiicoffee.com.
 - **Service Provider:** Third-party companies or individuals processing data on behalf of the Company.
 - **Usage Data:** Data collected automatically when you use the Service, such as IP addresses, browser type, and site interaction details.

2. Collection of Personal Data

2.1 Types of Data Collected

Personal Data

We may collect the following personal data:

- **Identifiers:** Name, email, phone number, address, ZIP code.

- **Internet or Network Activity:** Browsing behavior, IP address, device details, geolocation.
- **Payment Information:** We use third-party payment processors and do not store full payment details.

Usage Data

We collect information automatically, including:

- Your **IP address** and browsing activity.
- The type of **device** and browser you use.
- The **pages visited, time spent, and actions taken** on our website.

2.2 Use of Tracking Technologies

We use **Cookies, Web Beacons, and similar technologies** to:

- Enable website functionality.
- Improve user experience.
- Analyze site traffic and trends.

You can **opt out of non-essential cookies** through your browser settings.

3. How We Use Your Personal Data

We process your personal data for the following purposes:

1. **To provide and improve our Service.**
 2. **To manage user accounts and authenticate logins.**
 3. **To process transactions** and deliver products.
 4. **To communicate with you** about updates, offers, and service notifications.
 5. **For analytics and website optimization.**
 6. **To comply with legal obligations** and enforce our terms.
 7. **For business transfers**, including mergers or acquisitions.
